

America EV, Inc. Limited One Year Warranty for 2021 Model Year
Low Speed Vehicle versions (LSV)

1. Warranty:

AMERICA EV, Inc., hereby warrants to the Original Retail Purchaser that its new 2021 Model Year Pure Electric Low Speed vehicle (LSV) purchased from AMERICA EV or an authorized AMERICA EV distributor or AMERICA EV dealer shall be free from defects in workmanship and material under normal service and use as a Low Speed / community vehicle for a time period of One Year from the Original Retail Purchaser's date of purchase from AMERICA EV or an authorized AMERICA EV distributor or AMERICA EV dealer as listed at <http://americaev.com/>, subject to the provisions, limitations and exclusions contained in this Limited Warranty.

Limited One Year Warranty

For a period of One Year from the Original date of purchase from AMERICA EV or an authorized AMERICA EV distributor or AMERICA EV dealer the electric motor, transaxle, electronic speed controller, 48 volt to 12 volt converter, ignition switch, on/off solenoid and forward/reverse solenoids are warranted with respect to parts and labor against defect in material and workmanship.

2. Exclusions:

Excluded from and AMERICA EV warranty are fuses, light bulbs, lubricants, trim pieces, seats, routine wear items such as charger plug receptacle, brake shoes, brushes, bushings, engine mounts, mats, pads, shocks, batteries, maintenance adjustments, cosmetic deterioration and items which deteriorate or fail due to ordinary wear and tear. All items that are not specifically listed above are not covered under this warranty. Also excluded from any AMERICA EV warranty is damage due to a vehicle or component failure resulting from a cause other than defect, including but not limited to: unreasonable or unintended strain or use, improper installation of accessories, installation of parts or accessories that are not original equipment, overloading, accident, alteration, abuse or neglect. Also excluded from any AMERICA EV warranty are any transportation expenses for any warranty services.

3. Voiding of Warranty:

THIS AND ANY OTHER WARRANTY SHALL BE CONSIDERED VOID IF THE VEHICLE IS USED IN AN UNINTENDED MANNER OR IS ABUSED OR SHOWS ANY INDICATION THAT IT WAS ALTERED IN ANY WAY, INCLUDING, BUT NOT LIMITED TO: MODIFICATION OF THE POTENTIOMETER, BRAKING SYSTEM, STEERING, TRANSAXLE, OR OTHER OPERATING SYSTEMS OF THE VEHICLE TO PERFORM OUTSIDE AMERICA EV SPECIFICATIONS. THE WARRANTY IS ALSO VOID IF THE VEHICLE INVOLVED SHOWS INDICATIONS THAT REASONABLE OR NECESSARY MAINTENANCE AS OUTLINED IN OWNER'S MANUAL WAS NOT PERFORMED AT THE TIME AND IN THE MANNER SPECIFIED.

4. Sole Remedy:

AMERICA EV's liability under this limited warranty or in any action whether based upon warranty, contract, negligence, strict product liability, or otherwise, shall be the repair or replacement at AMERICA EV's option, of the vehicle or component thereof that AMERICA EV deems to be defective. Replacement shall mean furnishing, during the applicable limited warranty period, a new or factory reconditioned vehicle or covered component thereof that is identical or reasonably equivalent to the warranted product or component at no cost to the purchaser. Repair shall mean remedying a covered defect in the vehicle or component thereof at no cost to the purchaser during the applicable limited warranty period. If AMERICA EV elects to repair the vehicle it may provide factory-reconditioned parts or components. All parts and components replaced under the limited warranty shall become property of AMERICA EV.

5. How to Make a Warranty Claim:

To make a warranty claim under this limited warranty, you must present the vehicle or defective component to an authorized AMERICA EV distributor or AMERICA EV dealer or send the defective component, freight prepaid, to the following:

ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WHICH EXCEED THE OBLIGATIONS OR TIME LIMITED STATED IN THIS WARRANTY ARE HEREBY DISCLAIMED BY AMERICA EV AND EXCLUDED FROM THIS WARRANTY. AMERICA EV MAKES NO WARRANTY OR GUARANTEE OF VEHICLE PERFORMANCE UNDER VARYING TERRAIN INCLUDING BUT NOT LIMITED TO HILLS, SNOW, OR WET AREAS SUCH AS MARSH OR SWAMP LANDS. THE PURCHASER AND AMERICA EV EXPRESSLY AGREE THAT THE REMEDY OF THE REPLACEMENT OR REPAIR OF THE DEFECTIVE VEHICLE OR COMPONENT THEREOF IS THE SOLE REMEDY OF THE PURCHASER. AMERICA EV MAKES NO OTHER REPRESENTATION OR WARRANTY OF ANY KIND, AND NO REPRESENTATIVE, EMPLOYEE, DISTRIBUTOR OR AUTHORIZED DEALER OF AMERICA EV HAS THE AUTHORITY TO MAKE OR IMPLY ANY REPRESENTATION, PROMISE OR AGREEMENT, WHICH IN ANY WAY VARIES THE TERMS OF THIS LIMITED WARRANTY. IF ANY PROVISION IN THIS WARRANTY IS HELD BY AN ARBITRATOR OR COURT OF THE COMPETENT JURISDICTION TO BE INVALID, VOID, OR UNENFORCEABLE, THE REMAINING PROVISIONS SHALL NEVERTHELESS CONTINUE IN FULL FORCE WITHOUT BEING IMPAIRED OR INVALIDATED IN ANY WAY.

7. No Consequential Damages

IN NO EVENT SHALL AMERICA EV BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING, BUT NOT LIMITED TO: LOSS RELATED TO PROPERTY OTHER THAN THE VEHICLE, LOSS OF USE, AND LOSS OF TIME, INCONVENIENCE, OR ANY OTHER ECONOMIC LOSS.
